- 1) This is an entry-level civilian position responsible for assisting in the day-to-day operation of the police department.
- 2) The community service officer will assist patrol officers in handling community service related calls.

(d) Essential Knowledge, Skills and Job-Related Experience Required

- 1) Ability to drive a motor vehicle; possess and maintain a valid Wisconsin Drivers license.
- 2) Knowledge of Defensive Driving techniques.
- 3) Knowledge of the precautions necessary to work safely in and around Vehicular traffic.
- 4) Ability to gather information and complete reports.
- 5) Ability to assist and communicate with the public.
- 6) Ability to maintain effective relationships with other employees.
- 7) Ability to understand and carry out oral and/or written instructions.
- 8) Ability to adapt to quickly changing work environment.

- 2) Posses a valid Wisconsin motor vehicle operator license.

- 1) Issue Parking tickets, warning notices and citations for animal, bicycle or other local ordinance violations.

- 3) Direct traffic and assist with crowd control at accidents, fire scenes, Disaster scenes and other times under the direction of a patrol officer.

- 6) Finger print citizens.
- 7) Keep records and enforce junked/stored vehicle ordinances.
