## **January Financial Reports**

Discussion regarding when 2019 final budget numbers will be available and questions on the January Restricted Account amount of \$8,477.66. Nowak stated that the Finance Dept. will forward the final numbers when they are available and she will check into the Restricted Account and report back to the Committee. Van Berkel made a motion to approve the January 2020 financial report. Gertz seconded. Motion carried.

CD Maturity Outlook: Discussion on monitoring the maturity dates and rates that are available at the time of a CD's maturity vs the existing rate on the CD to make sure we are obtaining the best interest rate possible. McGinnis made a motion that Nowak, Van Berkel and Feldt evaluate and summarize the Center's current CDs and review best interest rates and length of CD when they come due. Seconded by Gertz. Motion carried.

Van Berkel made a motion to proceed to request the City Board of Public Works to approve the budget \$515,475.38 to complete the Nelson Overlook project. Seconded by McGinnis. Motion carried.

Memorial Wall: Discussion on other options such as a touch screen which the marketing company said is very feasible, but having just a stand-alone screen may not be impactful. Committee decided that more options are needed and est. costs. Van Groll made a motion to create a separate committee of Carlson, Manion, Nowak and Feldt to work on recommendations and bring suggestions and costs to the Committee for review and approval. Seconded by Driessen. Motion carried.
