## **NEW HOUSING FEE REPORT – JANUARY 2021**

The City of Kaukauna charges the following fees for residential development. The fees listed are in effect as of December 31, 2020 and may be amended from time to time as impose by the State of Wisconsin, the Heart of the Valley Metro Sewerage District, Kaukauna Utilities, the City of Kaukauna or any other entity with legal authority to impose charges for residential development in the City of Kaukauna.

- Building permit fee schedule (see attached)
- A \$250 per residential unit park fee for new plats and certified survey maps. City may accept land dedication in lieu of park fees.
- Subdivision plat review fees \$200
- Water/sewer connection fees (see attached)
- There is a charge for the City's inspection of public infrastructure placement when needed at the following rates:

Planning / Engineering Technician: \$43/hour

o Engineer: \$58.50/hour

Project Engineer: \$68/hour

- Erosion control permit (see attached)
- Storm water permit (see attached)

In 2020 the following fees were imposed related to residential construction, remodels or development, except where noted otherwise:

Residential New Construction: \$74,742.12 (\$9,717.80 Two-Family + \$65,024.32 Single-Family)

Residential Remodel/Additions: \$268,061.60

Electrical: \$28,809.16 (This number includes commercial electrical permit fees as permits are aggregated) HVAC: \$18,237.26 (This number includes commercial mechanical permit fees as permits are aggregated) Plumbing: \$39,840.40 (This number includes commercial plumbing permit fees as permits are aggregated) Residential New Sewer Connection: \$143,174.00 (\$26,212.00 Two-Family + \$116,962.00 Single-Family)

**Total Permit Fees:** \$572,864.54 includes all residential including remodels (includes commercial electrical, mechanical and plumbing fees as permits are aggregated)

**Construction value is \$16,979,000.00** for new residential construction (not including remodels) in 2020. Permit fees are approximately **3.37% of construction value**.

Approximately \$304,802.94 in fees are associated with new housing units in 2020 (\$304.802.94 divided by 99 units equals \$3,078.82 per unit).



## **SEC. 6.08 CONNECTION FEES**

(1) Said Connection Fee shall be paid to the District by the Municipality within which the connection is made no later than thirty (30) days after the end of the calendar month within which the actual connection is made.

2(e) Any Connection Fee(s) not so paid by the due date shall bear interest at the rate of 18.0% per annum from date of connection until paid to HOVMSD.

## **Application Fee**

Permit application fees are as follows:

- Sites with less than 1 acre of disturbed area = \$200 (fixed fee).
- Sites with 1 acre or more of disturbed area = \$250 plus \$0.0002 / sq.ft. of disturbed area.

## **Inspection Fee**

Permit inspection fees are as follows:

- Sites with less than 1 acre of disturbed area = \$25 / week of land disturbance (fixed fee).
- Sites with 1 acre or more of disturbed area = \$250 plus \$25 / week of land disturbance.

#### Forfeitures/Fines

Forfeitures/fines vary from \$25 to \$500 for each day of non-compliance and each occurrence. Issuance of forfeitures/ fines will depend on if the violator is non-responsive or if the violation is blatant, intentional, repetitive or severe. The forfeitures / fines are as follows:

## **Application Fee**

Permit application fees are as follows:

- Sites with less than 20,000 sq. ft. of disturbed impervious area = \$200 (fixed fee)
- Sites with 20,000 sq. ft. or more of disturbed impervious area = \$500 plus \$0.0025 / sq.ft. of disturbed impervious area

## **Inspection Fee**

Permit inspection fees are as follows:

- Sites with less than 20,000 sq. ft. of disturbed impervious area = \$0 (fixed fee)
- Sites with 20,000 sq. ft. or more of disturbed impervious area = \$500

### Forfeitures/Fines

Forfeitures/fines vary from \$25 to \$500 for each day of non-compliance and each occurrence. Issuance of forfeitures/ fines will depend on if the violator is non-responsive or if the violation is blatant, intentional, repetitive or severe. The forfeitures/fines are as follows:
